### I. CALL TO ORDER

Mr. Tierney called the meeting to order at 10:00 a.m.

### II. APPROVAL OF AGENDA

Mr. Tierney solicited a motion to approve the agenda. A motion was made by Sheriff Millholland to approve the agenda. Ms. McCann seconded the motion. The Authority unanimously approved.

## III. APPROVAL OF THE MINUTES FROM THE APRIL, 2019 MEETING

Mr. Tierney solicited a motion to approve the minutes from the April 18, 2019 meeting. A motion was made by Ms. Heritage to approve the minutes. The motion was seconded by Mr. Ash. The Authority unanimously approved.

# V. OPERATIONAL UPDATE

Mr. Whitley reported that the ADP for FY19 was 613. The ADP in FY18 was 605. The FY19 Inmate Man Days reported as follows:

The Superintendent reported the ADP for Work Release as 34, CIWF 45, and Home Electronic Monitoring 15.

Minutes of Meeting July, 18, 2019

Mr. Whitley reported that the Out-Of-Compliance population is creeping up. Currently we are housing approximately 111. Previously our out-of-compliance population was 103.

The Superintendent reported the following Probation Activities:

- 568 probation referrals in 2019
- 16,961 hours of community service were completed
- Court costs/fines plus restitution totaled: \$92,690
- Misd. Successful Closure: 68%
- Felon Successful Closure: 63%

In the FY20 budget, the Local Probation Program was approved to hire an additional Case Manager. We are currently interviewing applicants.

Mr. Whitley reported the total number of placements in Pretrial in FY19 was 565. The average length of supervision for misdemeanants is 97 days and for felony charges is 202 days. The Superintendent reported the closure rate for successful misdemeanors is 85% and the successful felon rate is 75%.

Mr. Whitley explained the reason for the high cost of overtime is due to the staff vacancies.

The Superintendent reported the estimated fund balance effective July 15, 2019 is \$3,228,280.

Mr. Whitley reported \$1.23M, which includes interest, is the amount that will be reimbursement from the State for the Security System. Ms. McCann-Slaughter asked whether the fund balance reflects the States \$1.23M reimbursement for the new Security System. Mr. Whitley explained that it does not but the funds will be used toward the bond payment.

The Superintendent reported that the fuel tank had to be built and we are hoping for it to be install in the next month. The cost of constructing and installing the tank is \$94,316.
