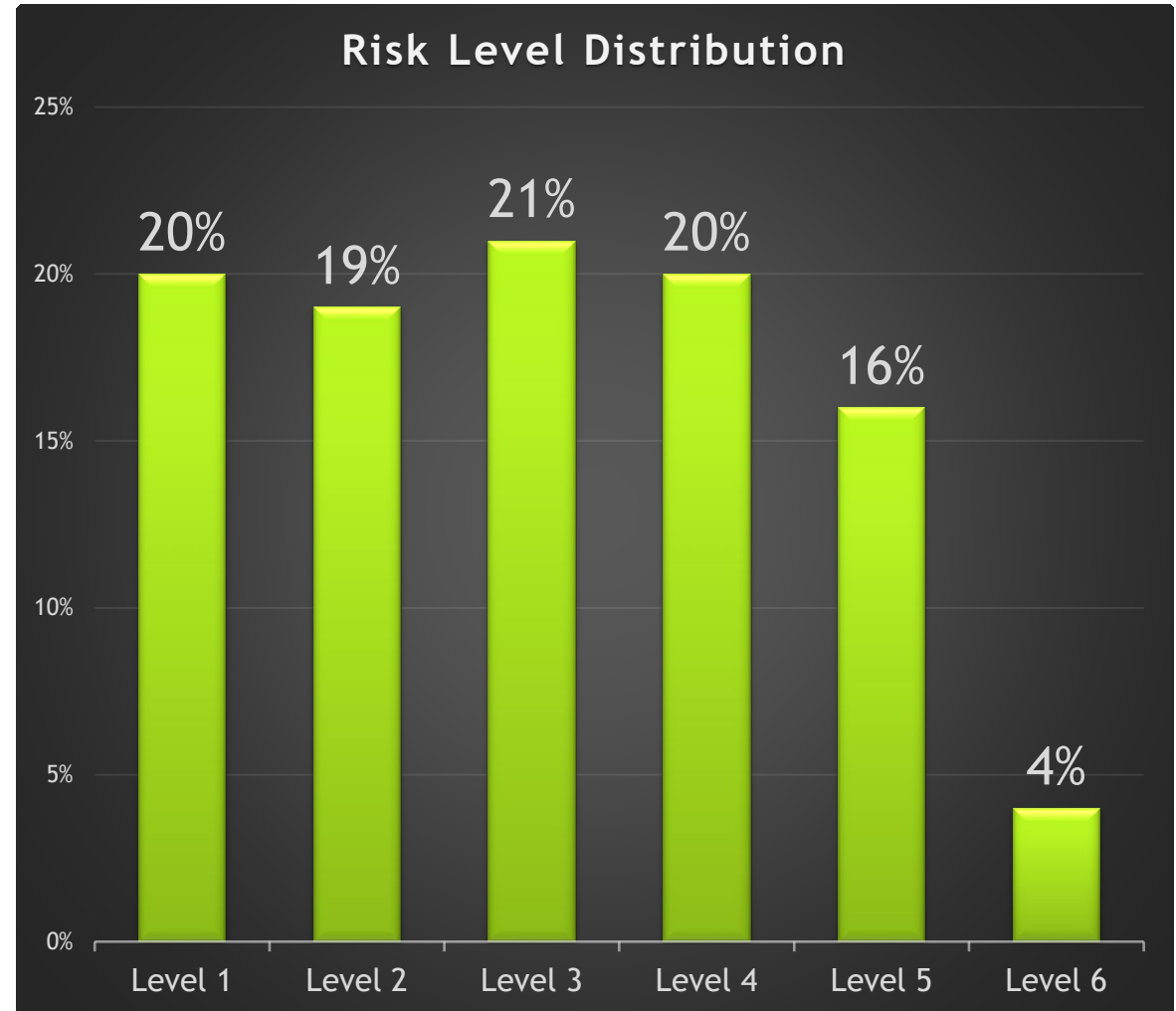
Investigation Performance Measures

- **Investigation Rate:** Rate of those defendants who should be investigated and are investigated. YTD FY 23 is 85%
- **VPRAI Completion Rate:** Rate that the Pretrial Investigator completes a Risk Assessment when making a recommendation. YTD FY 23 is 100%.
- **Praxis Concurrence Rate:** Frequency that the investigator recommends the decision indicated by the instrument. YTD FY 23 81%. DCJS encourages 85%.
- **Judicial Concurrence Rate:** Frequency that the Judge agrees with the recommendation of ODCS. YTD FY 32 55%.

Pretrial Outcome Measures

19

- **Overall Success Rate:** Ratio of successful completions to any violation during pretrial supervision.
- **Court Appearance Rate:** Percentage of defendants who attend every court appearance while under the supervision of ODCS.
- **Public Safety Rate:** Rate of defendants who are not arrested for a new offense occurring during the supervision period that results in the revocation of bail. Sub-section of this performance measure is if the new offense was a violent crime (Public Safety - violence).
- **Technical Compliance Rate:** Percentage of defendants whose bail is not revoked due to non-compliance behavior, for example positive drug/alcohol testing or leaving Commonwealth of VA.

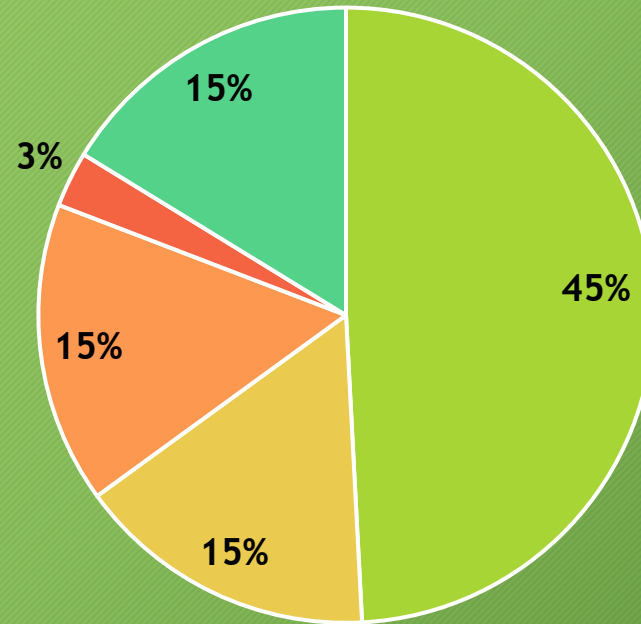

High Risk - Comp.

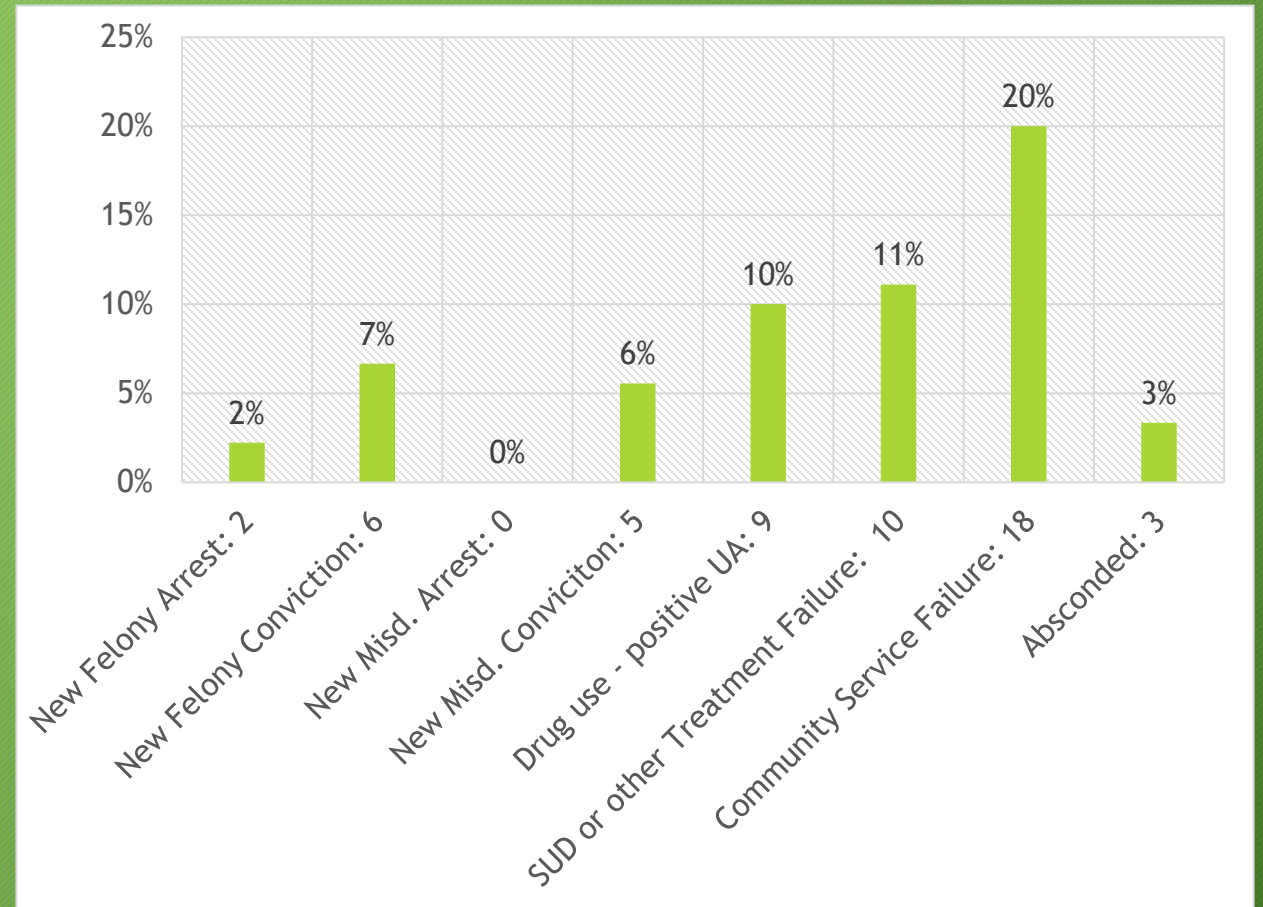
