Participants are prompt, reliable, motivated, cooperative, and desire full-time employment to maintain upon release.



Work Opportunity Tax Credit

Companies can receive a Federal Tax Credit for hiring individuals from target groups, such as a person hired within 1 year of being convicted of a felony or within 1 year of being released from prison for a felony conviction sentence.

Working Together

Through effective two-way communication, we can make the program a success:

- We review each inmate for eligibility based on their sentence, criminal history, and institutional adjustment. To be considered for Work Release, a participant shall not have a history of violent felonies within the past 5 years, shall not have a history of sex offenses, shall not have a history of escape within the past 5 years, shall not have an active protection order against him/her, and shall not have a poor jail adjustment or pattern of jail misconduct.
- We monitor all Work Release participants using GPS tracking technology.
- Notify Work Release of any changes in a participant's work schedule, status and performance.
- Report any obvious rule violations to Work Release.

- Submit a copy of your current city or county Business License or Contractor's license.
- Submit a cop of your Certificate of General Liability and Worker's Compensation Insurance.
