I. <u>CALL TO ORDER</u>

Sheriff Taylor called the meeting to order at 10:00 a.m.

II. APPROVAL OF AGENDA

Sheriff Millholland was appointed to filled the vacancy on the Personnel Committee. Sheriff Mosier, Mr. Butler and Sheriff Taylor were appointed to fill the vacancies on the Construction Committee.

V. PERSONNEL UPDATE

Mr. Whitley reported that NRADC has hired 7 officers from RSW Regional Jail, which is a savings to us because they come to us already certified.

Mr. Whitley reported that one of the biggest obstacles we face in filling vacant civilian positions is the nursing positions.

VI. OPERATIONAL UPDATE

Mr. Whitley reported the ADP July 1, 2015 thru December 31, 2015 was 677. The Superintendent reported that part of the reason for the current ADP is due to the fact the Department of Corrections only moves approximately 4 inmates per month. Our current "Out of Compliance" population is 85.

Mr. Whitley reported that the Security System Upgrade RFP will be posted/advertised January 25, 2016. Responses will be due March 15, 2016. The RFP that best meets the needs of the facility will be presented to the Facility's Financial Advisor. Then an RFP will be developed to obtain a bank loan. The results of the bank RFP will be presented to the Finance Committee. The Finance Committee will present recommendations to the Jail Authority. If approved, each jurisdictions will obtain approval from their Boards of Supervisors and the implementation of the project will begin.

Mr. Whitley provided a financial update for FY16 using the chart below:
